After graduating high school, he learnt and studied wide variety of disciplinary areas -- he did M. Lib. Sc. degree at University of Mysore and obtained First Rank with Dr. S. R. Ranganathan Memorial Medal. The doctoral study in LIS completed in the University of Madras under the title of "A Study of the Characteristics of Indexes in Philosophical Books with Reference to the Standards on Indexing". Meantime, completing Master degrees both in political science and in cost accounts and Diploma in Tamil, he was awarded Commonwealth Fellowship for Post-Doctoral research at the Department of Information Science, Loughborough University, United Kingdom.

Some hold that various and diverse background and interests cannot be helpful for the in-depth research and study as a scholar. But Dr. Babu has demonstrated that we should start to digging the foundation wider, in order to excavate the hole deeper. As we can see through his wide range of research, it can be a very useful advantage especially for the researcher and professor of library and information science to cope with this ever-changing age of information society. He has already written or edited 13 books, published more than 250 articles in various journals and proceedings including those in 12 international journals, and those in 41 national journals, and guided 23 doctoral students. The ability and achievements of Dr. Babu has been acknowledged by many instances of awards and prizes including Dr. S. R. Ranganathan Memorial Gold Medal by the University of Mysore; C. D. Sharma Best Paper Award; REDIT 2001 Best Paper Award; Commonwealth Fellowship for Postdoctoral Research; Prof. Parvathaneni Gangadhara Rao Memorial Award; Best Teacher and Researcher Award; and

most recently IATLIS – Motiwale Best LIS Teacher Award for the year 2011.
